**Re: Changes to Data Protection law**

You may be aware that from the 25<sup>th</sup> May, the rules around data protection are changing. The 'General Data Protection Regulation' (GDPR) will change how we can use your personal data and keep it safe, and will also strengthen your rights over your own data.

The point of this is to make sure sensitive or private information about you and your children stays safe. Whilst it is similar to the current Data Protection Act in many ways, there are a few differences, so we need to make a few changes at the school in order to ensure we remain compliant.

As part of our work to comply with the GDPR, we are re-seeking consent for using photographs of your child on our website and other school materials as well as Biometrics. We have enclosed this form, and would appreciate it if you could fill this out and return it to the school office by **Friday 18<sup>th</sup> May**. Please note that under the new regulations you have the right to withdraw consent at any point by written confirmation to the School Office.
