#### NARROWING THE GAP

#### St John's Catholic Comprehensive School - Pupil Premium

#### 1: Background

The Pupil Premium is a government initiative to target resources on those pupils deemed to be from a disadvantaged background. Specifically the Pupil Premium funding is calculated for those pupils who have been entitled to Free School Meals (FSM) at any point over the past 6 years (Ever 6) or those children who are service children, have been looked after for one day or more, are adopted or are under a special guardianship order or residential order. For the financial year 2016-7 funding is £935 per pupil and £1900 for a looked after child. The government has not dictated how Pupil Premium funding should be spent, but what is clear is that the money should be used to promote strategies which narrows the attainment gap between the highest and lowest achieving pupils.

Total number of PP in years 7-11 of 273 equates to 30% of the whole school.

#### 2.2 Ensuring PP funding was accessed by those eligible.

The school put procedures in place to try to assist those who were eligible for FSM to apply for and claim this entitlement. These procedures included a reminder email and letter sent to parents and a school meal audit at KS3 parents' evenings.

## 3: Strategies for narrowing the gap - an overview

St John's is a non-selective school with 30% being eligible for Pupil Premium funding. 23.4% have Additional Educational Needs (AEN). No single intervention provides a complete solution to the complex educational issues in any school and it is therefore a multi-faceted approach that we feel offers the best opportunities for pupils to succeed.

Interventions in our school come in a variety of forms: we aim to be specific to the needs of the students and not simply use generic strategies. Examples at St John's include:

- The continuation of **smaller group teaching in year 7** and the employment of a **primary trained staff** to support these pupils in their transition to secondary school and their progress.
- **PP priority given in lessons**, including marking.
- **Specific resources** to support learners in subjects e.g. provision of English, maths, science revision and text books.
- SLT individualised targeting and support of poor attendees.
- Individual financial support for uniform and extra-curricular activities.
- **SLT individual mentoring** of Year 11 PP students.
- **KS4 revision provision:** Monday to Friday programme.
- Year 11 interviews for VI form: students targeted to specific members of SLT based on need.
- SEN interventions for SEN PP students: SENCO and team personalise interventions/ support for PP students who are also SEN. E.g. Lexia, HW club for SEN students, mentoring of SEN students.
- Year 10 HW drive: detention set for those with amber or red HW status.
- **Inclusion in student voice:** e.g. anti-bullying, safe space, Year 11 questionnaire on what would help them learn better.
- **Pilot** run of VI form students mentoring **Year 11 maths**.
- Audit of year team interventions to improve PP attendance figure: from December 16 to March 17 attendance in Years 9, 10 and 11 improved.
- Additional GSCE Maths and English lessons for disadvantages pupils in year 11.

## **Pupil Premium and spending**

The total funding received by St John's for the 2016-7 academic year was  $\pounds$ 264,250. The funding is spend in a variety of ways with the direct and explicit aim of narrowing the attainment gap between the highest and lowest achievers. This includes investment in both academic and pastoral initiatives. A breakdown of expenditure for 2015-6 is shown below.
